
MEMORANDUM

On the recommendations of the Search-cum-Selection Committee, the Competent Authority of the Indian Council of Agricultural Research is pleased to approve the appointment of **Dr. Sunil Archak, Senior Scientist, National Bureau of Plant Genetic Resources, Pusa, New Delhi-110012**, as ICAR National Fellow for his research project, "**Development and implementation of Novel Algorithms and Software Modules for PGR Informatics**" on the following terms and conditions:

1. The award carries a pay scale of Rs. 37,400 – 67,000 with Research Grade Pay of Rs. 10,000/- per month as per Central Government rates along with allowances as admissible in the ICAR.
2. The tenure of the award will be for a period of 5 years or until further orders. The tenure may be renewed further after a Peer Review but not beyond the age of 60 years.
3. The terms and conditions will be in accordance with the rules governing ICAR National Fellowship (copy enclosed).
4. ~~You~~ shall give an undertaking in the prescribed pro-forma to the effect that patent rights in respect of the discoveries and inventions and the technical and engineering "Know-how" of processes that may develop during the course of ~~the~~ services with the ICAR, shall vest in the ICAR.
5. If the project involves the utilization of genetically engineered organisms, ~~You~~ should submit an application through Institutional Bio-safety Committee. He/she should also declare that while conducting experiments, the Bio-safety Guidelines of the concerned department/sponsoring institution would be followed in toto.
6. If the project involves field trials/experiments/exchange of specimens etc., ~~You~~ will ensure that ethical clearance would be taken from concerned ethical Committee/Competent Authorities and the same would be conveyed to the Agricultural Education Division of ICAR before implementing the project.

Acceptance and joining report may please be submitted through the Head of the Institution alongwith the approved research project as per guidelines along with the detailed technical programme for the project with year-wise and head-wise budget requirement. The offer is valid upto three months only from the date of issue of this letter. The date of joining will be the date on which the Memorandum of Understanding (MoU) duly signed by the ICAR National Fellow Appointee and the Sponsoring Institution is accepted and signed by the ICAR.


